## **US Elections: The Economic Aftermath**

Last week, Barrack Obama made history by securing a second term in office. But with the President presiding over an unemployment rate of 7.9% and a potential 'fiscal cliff' awaiting him if he's unable to come to an agreement with Republicans over budget cuts the post-election euphoria that followed his victory in 2008 is somewhat short in supply.

UCL The Economist's Society is proud to be welcoming Giles Whittell (former Washington correspondent for the Times) to address some of the following questions. What is the reelection of Barrack Obama likely to mean for the world's largest economy? What are the potential effects for the eurozone and the wider global economy? Is the rejection of the Republican Party a reflection of the wider disaffection with western capitalism?

Giles Whittell is the Times' former Washington Correspondent. He spent six years as the paper's Los Angeles correspondent in the 1990s and two in Moscow covering Putin's rise to power and the second Chechen war. His latest book is Bridge of Spies, publishes in November 2010, about one of the great intelligence coups of the 20th century.
